This course explores the issues of religion, society, culture and identity in Israel. Israel is an emergent society composed of Jewish immigrants that arrived from more than 70 different countries. It is also a country that defines itself as "Jewish and Democratic" with a large minority containing 20% Arab citizens and other ethnic-religious groups. This course will present these different groups, discussing the interactions between them and the communities of their origin. It will likewise explore the changes in the culture and identity of these groups.

This course will present the "The Four Tribes" dynamics of Israeli society. This model, outlined by President Reuven Rivlin in 2015 posited that "secular" Jewish-Israelis, once the dominant group in the country, and especially amongst the elite, would no longer be a clear majority. Israel is rapidly moving towards being a minority-dominated society, comprised of four tribes: Ultra-Orthodox Jews, Religious Jews, Secular Jews, and Arabs.

#### **Course Objectives:**

- 1. Develop a deeper understanding of the complexities within Israeli society.
- 2. Understand Israeli society beyond the Middle East conflict.
- 3. Learn about the connections between Israeli minorities and other countries and societies in the region.
- 4. Engage in critical thinking, discussion, and analysis of the Multilayer Identities in Israel and the Middle East.
